We, the jury, find in favor of Patricia Johnson and against Camping World RV Sales, LLC and award damages as follows:


Past medical expenses incurred; and	\$33,035.25

We, the jury, find in favor of Edward Williams and against Camping World RV Sales, LLC and award damages as follows:

Past medical expenses incurred; and	\$12,055.75
Mental anguish, emotional distress, loss of enjoyment of life, if any.	\$25,000.00
Total Awarded	\$37,055.75

The Court having ascertained that this was the jury's verdict, and that it was in proper form, as is attached hereto, directed the Court Clerk to file the verdict. It is therefore, **IT IS ORDERED AND ADJUDGED**, that the Plaintiff, Patricia Johnson, is hereby awarded Judgment in the amount of \$233,035.25 as actual and general damages and that Plaintiff, Edward Williams, is hereby awarded Judgment in the amount of \$37,055.75 as actual and general damages.




