Comes the Petitioner and states as follows:

1. The Petitioner, Glenna R. Bevin, is a resident of Anchorage, Jefferson County, Kentucky, and has been a resident of such for a period of not less than 180 days preceding the filing of this Petition.

2. The Petitioner is 58 years of age; her year of birth is 1965; she was born in Cherokee, Alfalfa County, Oklahoma. Petitioner presently resides in Anchorage, Jefferson County, Kentucky 40223. The Petitioner is not employed outside the home.

3. The Respondent, Matthew G. Bevin, is 56 years of age; his year of birth is 1967; he was born in Colorado. Respondent presently resides at 804 Evergreen Road, Anchorage, Jefferson County, Kentucky 40223. The Respondent is self-employed.

4. The parties were married to one another in Newport, Newport County, Rhode Island on June 8, 1996 pursuant to a license issued in such place and where said marriage is so registered.

5. The parties have been separated for over one year.

6. The Petitioner is not now pregnant.

7. Nine children resulted from this marriage; however, only two remain minors and therefore subject to the jurisdiction of the Court, namely, **D.B, age 13, date of birth, 2009** and **J.B., age 16, year of birth, 2006**. The Petitioner believes the parties should have joint custody of the parties' children with her serving as primary residential parent.

8. (a) The Petitioner has not participated as a party, witness or in any other capacity in any other litigation concerning the custody of the parties minor children in this or any other state;

(b) The Petitioner has no information of any custody proceeding concerning the parties minor children in a Court of this or any other state;

(c) The Petitioner knows of no person not a party to this proceeding who has physical custody or visitation rights with respect to the children.

9. The Respondent is able-bodied, fully employed, and able to support the Petitioner and the parties' children financially.

10. The Petitioner is unable to support herself in the manner to which she has become accustomed during the marriage and is in need of maintenance from Respondent, both *pendente lite* and permanent.


11. Petitioner does not have independent means to pay for her attorneys' fee and costs in this matter and requires assistance from the Respondent with regard to such.

12. The marriage between the Petitioner and the Respondent is irretrievably broken.

WHEREFORE, Petitioner, Glenna R. Bevin, prays for relief as follows:

- A. That a dissolution of the marriage between the Petitioner and the Respondent be granted.
- B. That the parties be awarded joint custody of the parties' children with her serving as primary residential parent.
- C. That she be awarded child support, both *pendente lite* and permanent, in accordance with the Kentucky Child Support Guidelines.
- D. That she be awarded maintenance, both *pendente lite* and permanent.
- E. That the debts and marital property of the parties be appropriately divided between them.
- F. That the Respondent be responsible for Petitioner's attorney's fees and the costs of this action.
- G. That she be granted any and all other proper relief to which she may be entitled.
