Jean Hensley, then age 74, underwent a surgery on 3-29-04 to remove an intrathoracic goiter. The surgery was performed by Dr. Robert Cerza of Cardiac Anesthesia Services at Cookeville Regional Medical Center. As Cerza attempted to intubate Hensley, her trachea was injured.

The condition was grave and while Hensley's trachea was repaired, she remained unconscious for nine weeks. She then went through a course of in-

patient rehabilitation and was not released from the hospital until July. Hensley has a permanent scar, as well as persistent coughing. Her voice is also affected – it is now unnaturally high-pitched.

In this lawsuit, Hensley alleged negligence by Cerza in injuring her trachea. Particularly, she was critical of Cerza for using too much force to pass the tube (which was too large as well), for failing to take adequate protections and finally for not altering his plan when trouble arose. The expert for Hensley was Dr. Dennis Doblar, Anesthesia, Birmingham, AL.

Cerza defended that his care was proper and that the simple fact that Hensley's trachea was injured did not equate to negligence. He also noted that once this complication developed, he properly responded to the emergency, his care saving her life. Defense experts were Dr. Alex Woodruff, Anesthesia, Ashland, KY, Dr. James Bailey, Anesthesia, Gainesville, GA and Dr. Francis Robicsek, Cardiothoracic Surgery, Charlotte, NC.

This case was tried for a week in Cookeville. The verdict was for Cerza
