### **Age Discrimination - Two deputy police chiefs with the City of Chattanooga alleged they were dismissed because of their age, the city hoping to use the money saved to higher younger (and less expensive) patrol officers**

T.E. Vaughn, then age 59, was a police officer for 36 years with the City of Chattanooga. By the Spring of 2007, he was a deputy police chief. A second deputy police chief was Charles Cooke, age 49. He too had been with the police force for years, his service totaling 27

years. In May of that year, the newly appointed police chief, Freeman Cooper, told the pair their jobs were being abolished. Despite their years of service, each was told they had three days to clear out their offices. They were given an opportunity to apply for a civilian job or even better they could retire.

The police chief would explain the decision was motivated by a combination of budgetary and administrative reasons. At a city meeting, it was explained that the \$240,000 saved by eliminating these two positions could be utilized to hire more patrol officers. Administratively, the new chief also wanted to put his own people in the command structure – the government pointed to proof there was animosity between the two deputy chiefs and the new boss.

A month later Vaughn and Cooke sued the police and alleged the abolishment of their positions represented age discrimination. They thought the “budgetary reasons” cited by the police was a code to mask naked age discrimination. That is, by eliminating two long-serving and distinguished deputies, the government could hire
