**COURT SUMMARY AND
 JUDGMENT UPON THE
 VERDICT**

May 24, 2022:

Plaintiffs Guy Willis, Sr., Adriel Willis, and Guy Willis, Jr., appeared in person and by attorney Christopher Blackburn. Defendant Sein Thu appeared by attorney Thomas Datzman. *Voir dire* is begun and completed. Plaintiffs and Defendant accept the Jury. A Jury of six (6) persons is now empanelled and sworn as provided by law. The Court, prior to the Opening Statements of counsel, now instructs the Jury as to the issues for trial, the burden of proof, the credibility of witnesses, and the manner of weighing testimony, giving the Jury, on its own motion, its Preliminary Jury Instructions numbered 1 through 14 inclusive. Said Preliminary Jury Instructions are now filed with the Clerk of this Court and ordered made a part of the record in this cause. Opening

Statements are made by counsel for Plaintiffs and Defendant. Presentation of evidence is commenced by Plaintiffs. Plaintiff rests. Defendant rests without presenting any evidence. Plaintiffs present no rebuttal evidence. A record of the Final Instructions is made. Closing Arguments are made by counsel for Plaintiffs and Defendant. The Court reads Final Jury Instructions Numbered 1 through 20. The Final Jury Instructions are now filed with the Clerk of this Court and ordered made a part of the record in this cause. The Jury retires at 4:47 p.m. to deliberate and returns at 5:49 p.m. with the following verdicts:

“We, the Jury, decide that the total of damages Guy Willis, Sr. is entitled to recover is \$30,000.00.”

“We, the Jury, decide that the total of damages Adriel Willis is entitled to recover is \$1,000.”

“We, the Jury, decide that the total of damages Guy Willis, Jr. is entitled to recover is \$1,800.00.”

The verdicts of the jury, executed by the Jury Foreperson, is ordered to be filed with the Clerk of the Court and made a part of the record of this cause. The Court indicates to counsel that it will enter judgment upon the verdict. The Court now enters judgment upon the verdict. Costs are assessed to Plaintiffs.

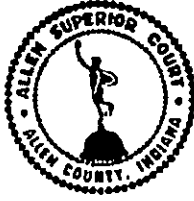
